Swiss companies; member of ASTAG and/or Carverband Bern-Solothurn	CHF 715.00 / year* <i>per line</i>
Foreign companies (line operators)	CHF 880.00 / year* <i>per line</i>
Combined offer for line partners (a Swiss and a foreign company which are line partners)	CHF 1'4850.00 / year** <i>per line</i>
Per additional parking card	CHF 30.00 / year
Loss of the parking card (per card)	CHF 120.00 / card

\*\* 2 parking cards included in the price

### Temporary users (cash payment on the spot)

Parking ticket (valid for 1 hour)	CHF 15.00 / hour
Each additional hour	CHF 10.00 / hour

### Fix a billboard advertising/outdoor advertising

For fixing billboard/advertising on the terminal CHF 500.00 / year

This document is to be ordered from the Local Office.

#### **Note:**

The annual parking cards will be activated **after the payment of the fee**. That is why the Local Office explicitly recommends paying the fee immediately after the reception of the invoice to guarantee an activation of the card for the coming year (from the 1<sup>st</sup> January). Users of the parking cards have to pay the possible foreign bank charges themselves. Car-Terminal Neufeld may invoice any not paid bank charges.

### Major events / entrance with articulated vehicles/large goods vehicles

In case of planning larger scale travel or an event in the course of which the terminal is to be used by more than 5 vehicles, the Local Office should be contacted **in good time** – at least 10 days in advance – in order to coordinate the details (price included). The same applies for planned arrivals with articulated vehicles or other large goods vehicles. The organisers are obliged, in consultation with the Local Office, to ensure an **appropriate level of safety** on site (guidance personnel, barriers etc.) and to meet the costs involved.

**In general, the terms of use of the Car-Terminal Neufeld have to be followed.**
